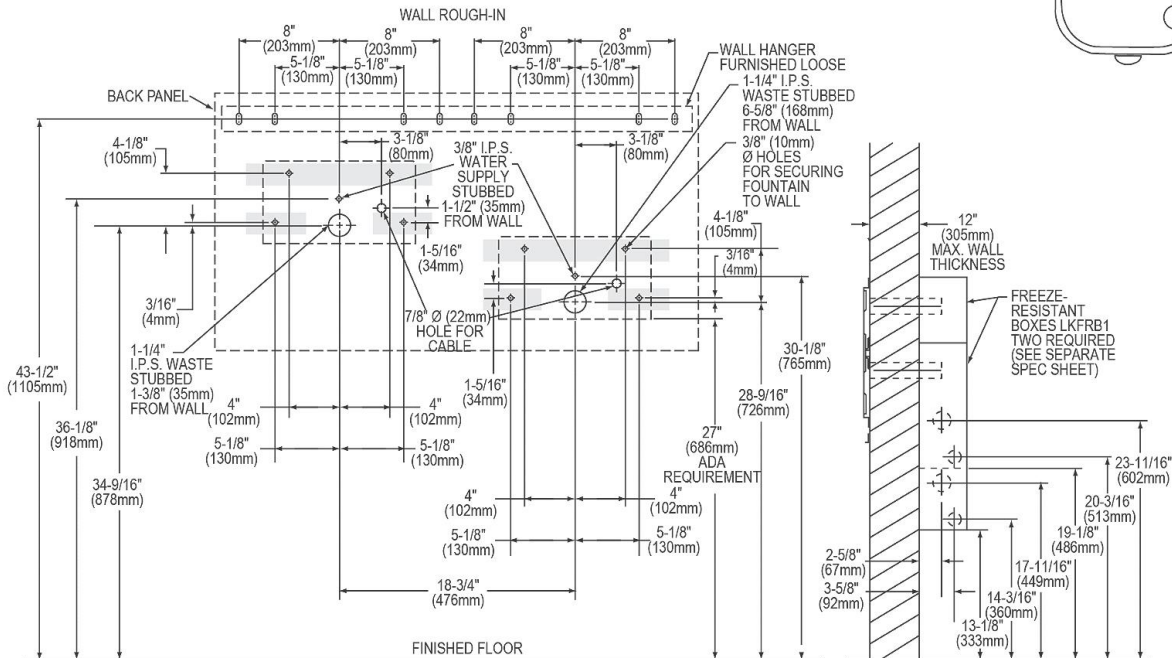
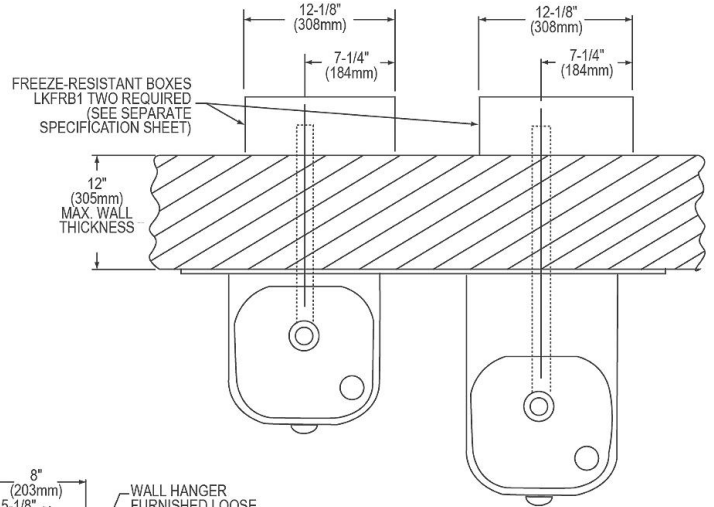
### OPERATION OF QUICK CONNECT FITTINGS



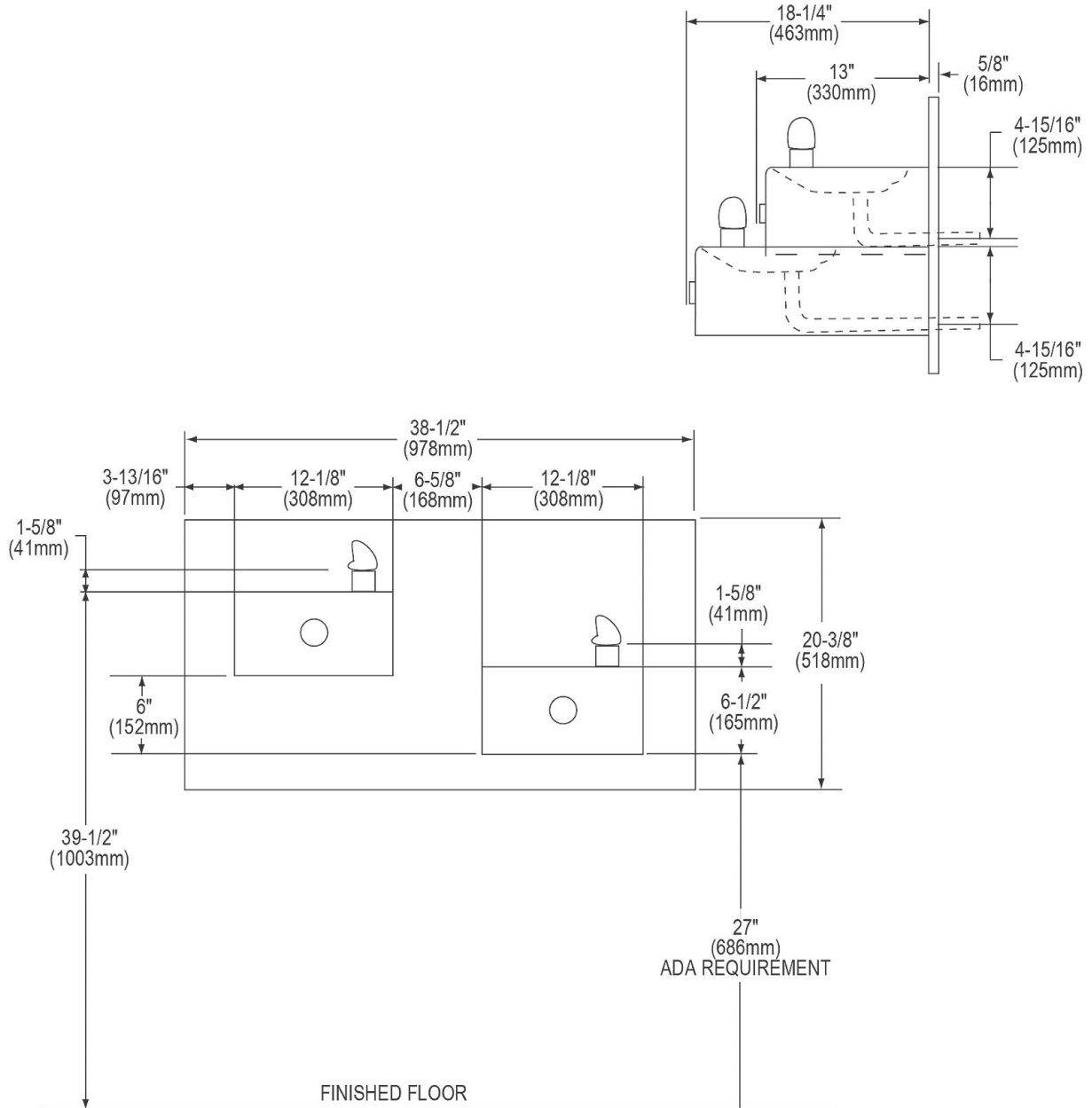
**WARNING:** The free-resistant box must be installed on an interior heated wall where the temperature does not drop below 50° F (10° C). The front of the box must have unobstructed air flow. Failure to maintain the interior wall temperature and the inside of the freeze resistant box above 50° F (10° C) can result in damage to the box which could result in unrestricted water flow.

**NOTE:** When using MP20 Surface Mounting Plate, remove the wall hanger and back panel channels. See separate specification sheet for details on MP20 Surface Mounting Plate.

**NOTE:** Reinforce the wall in the shaded areas to support up to 300 lbs. static load.
