The use of a copper alloy surface is a supplement to and not a substitute for standard infection control practices; users must follow all current infection control practices, including those practices related to cleaning and disinfection of environmental surfaces.

Copper alloy surfaces are for use only in non-food zone areas.

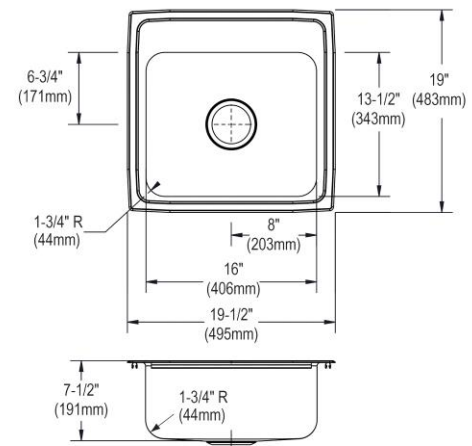

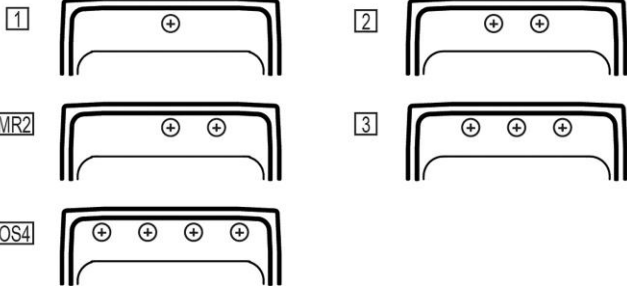

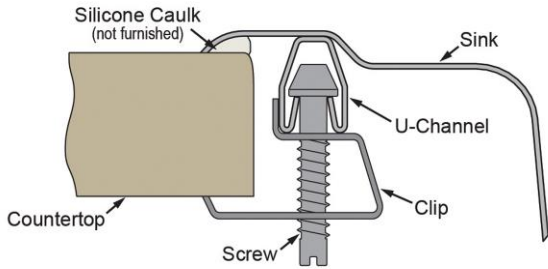
