18-3/8" x 17-3/8" (467mm x 441mm) with 1-1/2" (38mm) corner radius

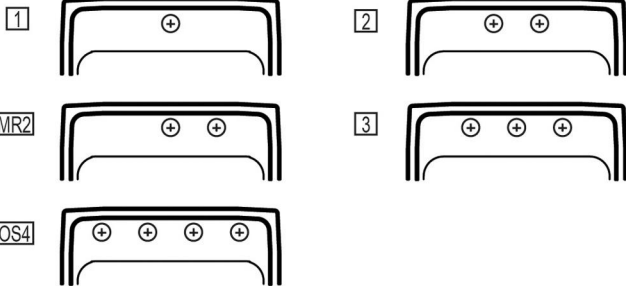

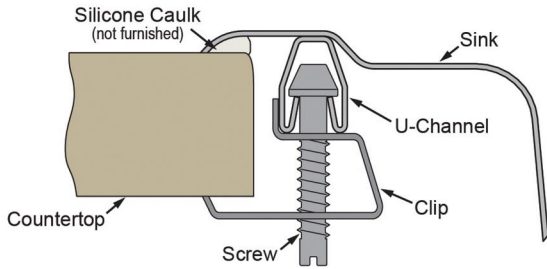
