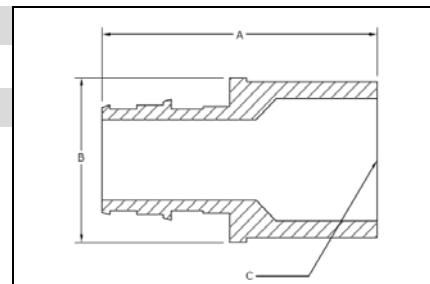

ProPEX® Brass Sweat Adapter transitions Uponor PEX tubing to copper pipe for use in hydronic heating and cooling systems.<sup>1</sup> One end of the adapter is manufactured with the Uponor ProPEX fitting for connection to Wirsbo hePEX™ tubing and the other end is manufactured to adapt copper sweat connections. These adapters are not safe for direct burial in soil.
